


# COURSE EVALUATION REPORT

2018-2019 SEMESTER 2

#### INTRODUCTION

The University of Bahrain is committed to transparency and accountability in support of its goal to provide world-class teaching and learning. Student feedback is an essential element in the continuous quality improvement (CQI) system that the University has established. The courses evaluation survey provides an institutional system for collecting feedback on key elements of teaching, learning and students experience. Feedback is obtained and utilized to improve academic courses and programs, learning environment, and teaching and learning. By publishing this report, we are committed to:

- Promoting public accountability
- Seeking to improve academic programs and services
- Encouraging quality and excellence

#### HOW DOES IT WORK

Each semester students rate the quality of our courses. Since 2016, the evaluation of courses has been conducted electronically via the Student Information System (SIS). During the evaluation period, the students rate each course (section) they are enrolled in. The results of each section are aggregated and a report for the section is generated. The aggregated results are grouped per faculty member to correlate the evaluation results with the performance of faculty members. Due to the nature of this evaluation, the identities of the students who participated in the course's evaluation survey are kept anonymous. All data is confidential and only aggregated data is made available for improvement purposes. faculty members will be able to view their evaluation results. Additionally, Head of Departments and Deans are granted access to view the results for their faculty members. In addition to the online results available via SIS, this report provides overarching information about the second semester 2018 - 2019 course evaluation.

Satisfaction Rate

During the second Semester 2018 - 2019, Students participated in evaluation their courses. **1,398** different courses offered over **3,679** sections in 9 colleges, English Language Centre, Confucius Institute, and the French Studies Centre were included in the survey. These courses are taught by **871** full-time and part-time faculty members. Each student is eligible to cast his/her opinion for each registered section. The survey shows that the University maintained its satisfaction rate to achieved a positive **83% (4.16** / **5.0)** satisfaction rate.

The survey evaluated the students' satisfaction with regard to:

- Organization and planning of the lectures;
- Resources;
- Syllabus and course material;
- Teaching methodologies;
- Delivery of content;
- Teaching skills;
- Faculty members' knowledge and specialization;
- Provided feedback, support and encouragement to students and
- Suitability of assessment.




Figure 1 Response rates


The Survey recorded **42**% response rate, where **45,256** evaluation sheets out of **106,840** eligible evaluation were submitted survey. The following are the top three colleges that recorded the highest survey response rates:

- Bahrain Teachers College
- College of Applied Studies
- College of Health Sciences

In general, the response rate shows that a significant number of students participated to provide their feedback to improve the provisions at the University.

More than 95% of faculty members received an overall satisfaction rate of above 70%. This clearly shows the satisfaction of students with the quality of learning and teaching at the University. The University will continue its efforts into sustaining these positive results via its various quality assurance, professional development, and capacity building efforts. Furthermore, the University plans to offer the first postgraduate certificate in quality assurance and accreditation in the region. This qualification is anticipated to further contribute to the professional development of faculty members and quality of provisions.

#### **COLLEGES SATISFACTION RATE**

The students showed an overall average satisfaction rate of 83%. Ten (10) out of 12 entities of the University achieved overall satisfaction rates of 83% or above. In general, all entities received comparable satisfaction rates. Despite the College of Health Science received the lowest satisfaction rate of 79%, this result is still within acceptable margins of the overall average satisfaction rates. The following entities achieved the highest satisfaction rates:

- College of Applied Science
- Bahrain Teachers College
- College of Law
- French Studies Center
- Confucius Institute




Figure 3 Satisfaction Rate


# SURVEY QUESTIONS RATE
